

Microsoft Offer 2025 Terms and Conditions

Qualified Purchasers receive Promotion Savings with the purchase of an Eligible Product and a Promotion Product. This offer is subject to the terms and conditions herein, and capitalized terms are defined below.

PROMOTION PERIOD:

The promotion begins December 12, 2025, and continues through June 20, 2026, (the “**Promotion Period**”) in the United States of America (“**Qualifying Country**”).

QUALIFYING LOCATIONS:

Brick-and-mortar Apple Store locations, apple.com, Apple Store App, and 800-MY-APPLE in a Qualifying Country (each a “**Qualifying Location**”). Eligible Products (as defined in the chart below) must be purchased and delivered within the same Qualifying Country. Orders of Eligible Products from a Qualifying Location that are placed during the Promotion Period and ship after the end of the Promotion Period are eligible to receive Promotion Savings (as defined in the chart below).
